Notice of Invitation to Bid

Revise the 4th paragraph to read:

Deadline for Receipt of Bids. Sealed bids must be received in the Airport Administrative Offices, located at 100 Bowen Loop, Suite 200, Charlottesville, VA, 22911, by the following deadline: 2:00 p.m., local time, on May 10-24 31, 2017. The exterior face of each sealed bid shall be marked to show: the bidder's name and address; the bidder's Virginia contractor license or registration number in accordance with Va. Code Sec. 54.1-1103; and the Project Name, "Pedestrian Access Ramp & Canopy Systems". Bids timely received and properly marked will be opened publicly and read aloud, beginning at 2:15 p.m. on May 10-24 31, 2017, in the Airport Terminal Building Conference Room, 1st Floor, 100 Bowen Loop, Charlottesville, VA 22911.

Section A – Invitation for Bids

Revise the 1st paragraph under "Competitive Sealed Bid Procedure" (page 3) to read:

This procurement is being conducted as a competitive sealed bidding process. Each bid must be received by the Authority on or before 2:00 p.m., local time, on Wednesday, May 102431, 2017 ("Submission Deadline"), at the Airport Administrative Offices, 100 Bowen Loop, Suite 200 Charlottesville, VA 22911. Bids must be mailed or delivered to the Authority. Bids submitted by fax, email or other means will not be considered. Each bidder is responsible for assuring timely receipt of its bid by the Authority. The Authority will not open or consider any bid(s) received after the Submission Deadline.

Revise the 3rd paragraph under "Competitive Sealed Bid Procedure (page 3) to read: Bids received on or prior to the Submission Deadline will be opened publicly and read aloud, beginning at **2:15 p.m. on May 10-24 31, 2017**, in the Airport Terminal Building Conference Room, 1st Floor, 100 Bowen Loop, Charlottesville, VA 22911 ("Bid Opening").

Section B – Bid Forms

Replace the Bid Forms (pages 1-3) with the *Revised* Bid Forms (pages 1-3) included as Attachment "A" to this Addendum No. Three (3).

The Base Bid shall include a Contractor allowance of \$5,000.00 for additional exterior lighting upgrades to the elevator column, which may include replacement of the light fixtures at each opening of the elevator door and the light fixture on the ceiling between the lower elevator door and elevator mechanical room. The allowance shall be based on replacing up to five existing fixtures. This allowance shall be shown as part of the Contractor's schedule of values that will be prepared prior to construction. The Airport Management will make final selection of the light fixture(s) to be installed under this allowance.

Sheet S101 – Foundation Plan

Strike through the final sentence of Division 3 – Concrete, Note #5 to show as: Bars shall be cut and bent cold before applying coating material.

QUESTIONS AND ANSWERS

- Q1. Can the bid due date be extended and if so when are the bids due?
- **A1.** Yes, the bid period has been extended by 1 additional week as part of Addendum No. Three (3). The bids are now due at **2:00 p.m.**, **local time**, **on Wednesday**, **May 31**, **2017**. Bids received will be opened publicly and read aloud starting at 2:15 p.m. in the Airport Terminal Building Conference Room, 1st Floor, 100 Bowen Loop, Charlottesville, VA 22911.
- **Q2.** If additional questions are developed after issuance of an addendum, can the question cut-off date be extended?
- **A2.** Yes, questions shall be in writing utilizing the "bidder question form" included in the project specifications (Section A, page 32). - **A3.** No, the allowance is for replacing up to five existing fixtures on the elevator door opening side of the elevator column. This includes two globe lights at the upper level door opening, two globe lights at the lower level door opening, and one ceiling mount light between the lower door opening and the mechanical room.

- **Q4.** There appears to be a conflict on the reinforcing steel requirement, please confirm if epoxy coating shall be performed prior to fabricating or after fabricating?
- **A4.** The note on Sheet S101 has been clarified as part of Addendum No. Three (3) to remove the conflict. Epoxy coating shall be performed prior to fabricating in accordance to ASTM A775.
